To provide for the repeal of redundant by-laws adopted by former municipalities in the jurisdiction of the City of Cape Town; and to provide for matters incidental thereto.

BE IT ENACTED by the Council of the City of Cape Town, as follows:

1. Repeal of By-laws

The by-laws listed in the Schedule, which were adopted by former municipalities, the areas of which were incorporated in the City of Cape Town, are hereby repealed, insofar as they are applicable in the area of jurisdiction of the City of Cape Town.

2. Short title
