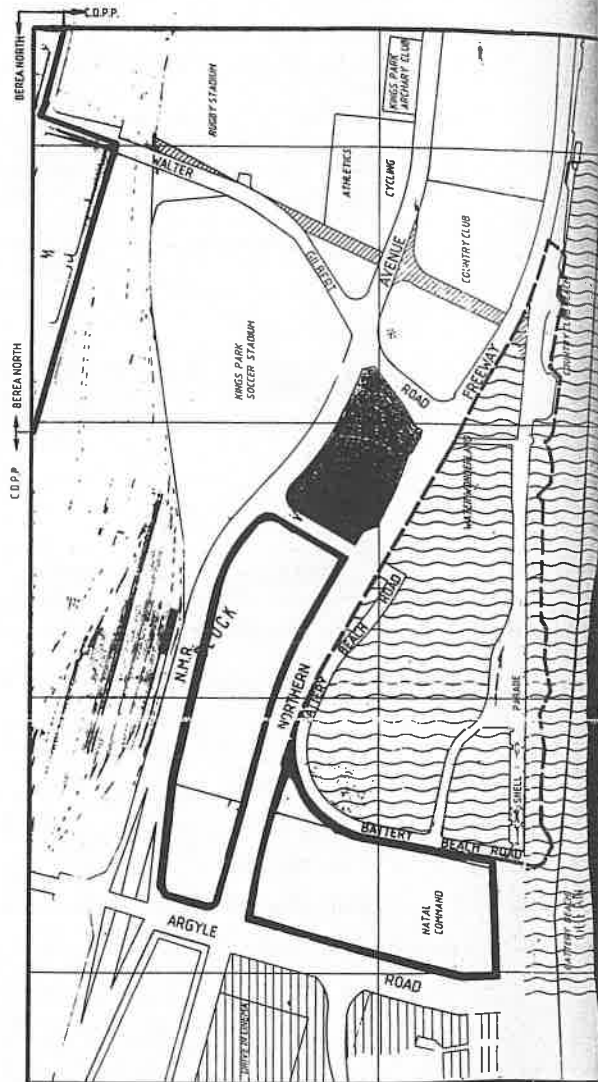

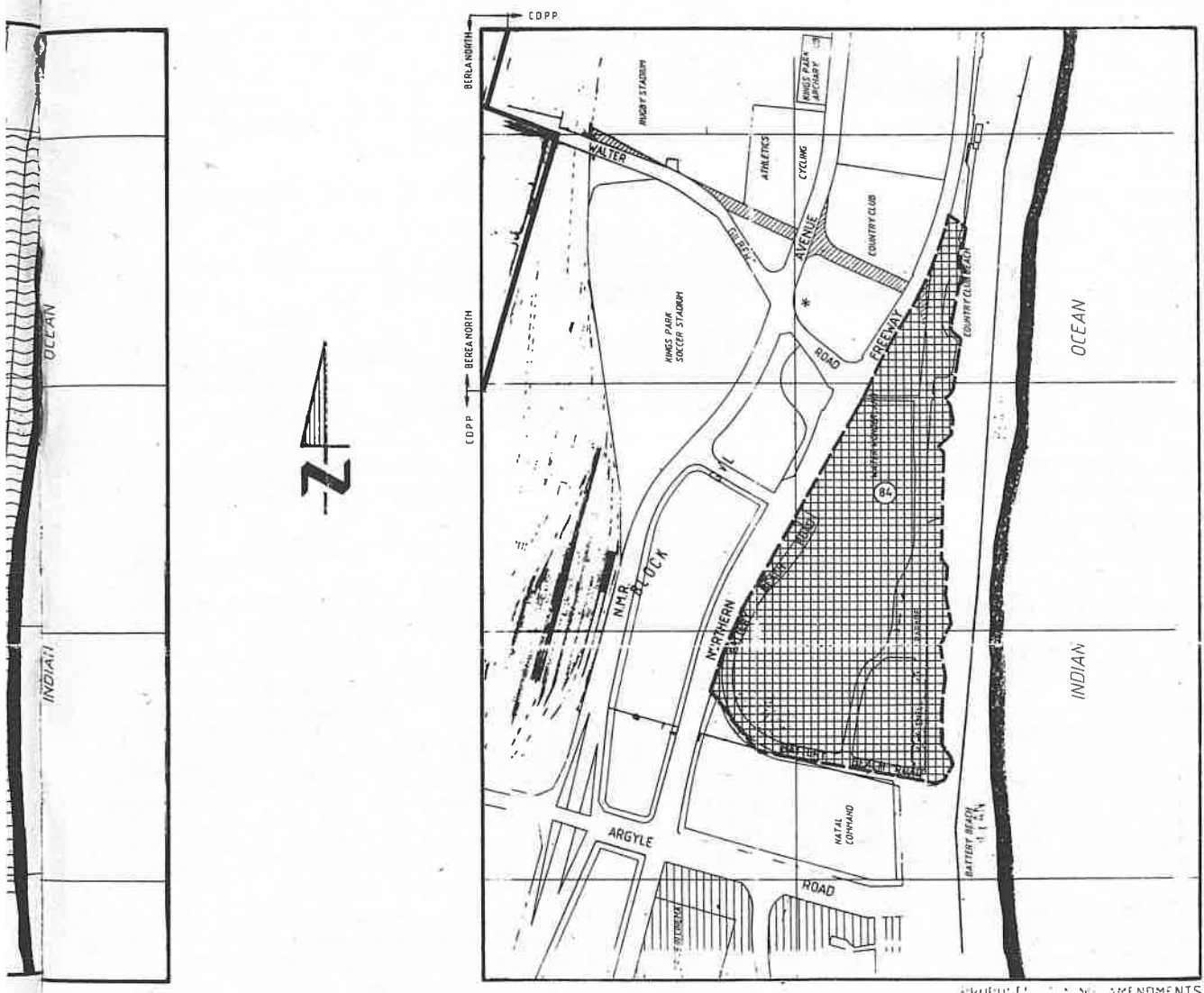

AMENDMENT TO BYLAWS RELATING TO FIRE BRIGADE SERVICES

1. The deletion of section 13(1)-(4) and the substitution thereof of the following subsection:

13.1. LICENCE TO DEAL IN FIREWORKS

A person wishing to deal in fireworks, will make application to the South African Police Services for a licence to deal in fireworks. The designated fire officer may submit the applications on behalf of the dealers. On receipt of the licence the designated fire officer will inspect the premises of the dealer and should the building requirements be met will issue a permit to trade in fireworks. Only when the permit has been issued may the dealer accept delivery of fireworks.

13.1.1 REQUIREMENTS FOR THE HANDLING AND STORAGE OF FIREWORKS

13.1.1.1 Premises in which fireworks are handled preferably should have at least two exits. Where any premises have only one exit the fireworks shall be kept at the rear (relative to the exit) of the premises.

13.1.1.2 The doors to the exits shall be kept **unlocked and unbolted** during trading hours and a **clear passage** shall exist between the counters holding the fireworks and all the exits, and no obstacles shall be placed in these passages.

13.1.1.3 A dealer must have a 9 kg dry chemical fire extinguisher which must be serviced annually on his premises in a readily accessible position or as determined by a designated fire officer.

13.1.1.4 A dealer may keep on his premises not more than 500 kilograms gross mass of fireworks, provided the fireworks, contained in their inner or outer packings are kept on shelves. When packs are opened these must be kept in glass cabinets or metal containers under lock and key and separated from goods of an inflammable or combustible nature.

13.1.1.5 Fireworks in excess of 500 kilograms gross mass must be stored in a fireworks magazine built according to the specifications as per the regulations.

13.1.1.6 A dealer shall not interfere with the inner packing of the fireworks, or allow or permit it to be interfered with.

13.1.1.7 Fireworks shall not be displayed in any window or any other place where such fireworks can be interfered with by the public.

13.1.1.8 Notices with 100 mm red lettering on a white background must be provided as follows:

- (a) to the outside of the premises in a prominent position adjacent to every entrance,

1. Artikel 13(1-4) te skrap en dit deur die volgende subartikel te vervang:

13.1. LISENSIE OM IN VUURWERKE HANDEL TE DRYF

Iemand wat in vuurwerke handel wil dryf, moet by die Suid-Afrikaanse Polisiediens om 'n lisensie aansoek doen om in vuurwerke handel te dryf. Die benoemde brandweeroffisier kan die aansoek namens die handelaars indien. By ontvangs van die lisensie inspekteer die benoemde brandweeroffisier die handelaar se perseel en indien daar aan die bouvereistes voldoen word, sal hy 'n permit uitreik om in vuurwerke handel te dryf. Die handelaar mag die aflewering van vuurwerke slegs aanvaar nadat die permit uitgereik is.

13.1.1 VEREISTES BETREFFENDE DIE HANTERING EN BERGING VAN VUURWERKE

13.1.1.1 'n Perseel waarop vuurwerke gehanteer word, moet by voorkeur minstens twee uitgange hê. Indien 'n perseel slegs een uitgang het, moet die vuurwerke aan die agterkant (met betrekking tot die uitgang) van die perseel gehou word.

13.1.1.2 Die deure na die uitgange moet gedurende handelsure **oopgesluit en ontgrendel** gehou word en daar moet 'n **duidelike deurgang** tussen die toonbanke waarop die vuurwerke gehou word en al die uitgange wees, en geen versperrings mag in hierdie deurgange geplaas word nie.

13.1.1.3 'n Handelaar moet 'n 9 kg-poeierbrandblusser op 'n redelik toeganklike plek op sy perseel, of soos deur 'n benoemde brandweeroffisier bepaal, aanhou, wat jaarliks versien moet word.

13.1.1.4 Die bruto massa van vuurwerke wat 'n handelaar op sy perseel mag aanhou, moet hoogstens 500 kilogram wees, met dien verstande dat die vuurwerke, omsluit deur hul binne- of buiteverpakking, op rakke gehou word. Wanneer pakke ooggemaak word, moet dit agter slot en grendel in glaskaste of metaalhouers gehou word en weggehou word van ware van 'n vlambare of brandbare aard.

13.1.1.5 Vuurwerke waarvan die bruto massa 500 kilogram oorskry, moet in 'n vuurwerkepakhuis geberg word wat ooreenkomstig die spesifikasies in die regulasies gebou is.

13.1.1.6 'n Handelaar mag nie aan die binneverpakking van die vuurwerke toring nie, of toelaat of duld dat daaraan getoring word nie.

13.1.1.7 Vuurwerke mag nie in 'n venster of op 'n ander plek vertoon word waar die publiek aan sodanige vuurwerke kan toring nie.

13.1.1.8 Kennisgewings in rooi letters van 100 mm op 'n wit agtergrond moet soos volg aangebring word:

- (a) aan die buitekant van die perseel op 'n prominente plek langs elke uitgang, ken-

notices reading "Dealer in Fireworks";

- (b) in prominent positions inside the premises, "No Smoking" signs in appropriate official languages.

13.1.1.9 Every dealer and every person employed in or about the premises shall take all due precautions for the prevention of accidents by fire and for preventing unauthorised persons having access to the fireworks and shall abstain from any act whatsoever which tends to cause fire. Goods of a dangerous nature such as inflammable liquids, acids, alkalis and the like shall not be kept on the same premises together with fireworks and safety matches, and Bengal matches shall be kept at least 5 metres away from the fireworks.

13.1.1.10 No persons shall smoke in, or take a naked light or fire into, premises where fireworks are kept, stored or being handled, nor shall any person be allowed to do so.

13.1.1.11 Every person on such premises shall abstain from any act whatsoever which tends to cause fire.

13.1.2 TRADE

13.1.2.1 A dealer in fireworks when purchasing or obtaining fireworks shall demand from the seller or supplier a properly executed, signed and dated invoice which he shall retain for a period of at least two (2) years for production on demand by an inspector.

13.1.2.2 A manufacturer or wholesale dealer shall furnish a properly executed, signed and dated invoice with each sale or supply of fireworks.

13.1.2.3 A dealer shall supply fireworks to the public only in the **sealed inner packing** as received from the manufacturer or wholesale dealer, provided that the packages are still in good condition.

13.1.2.4 A dealer shall not sell or allow or permit to be sold any fireworks to a child under the age of 16 years.

13.1.2.5 A dealer shall furnish each employee engaged in selling fireworks with a copy of the regulations and Bylaws and of the conditions attaching to his licence to deal.

13.1.2.6 A dealer shall keep a register in which full particulars of each transaction and the aforementioned licence number shall be recorded. This register shall be kept up to date and be available for inspection at any time and shall not be destroyed until after the lapse of two (2) years from the date of the last entry.

13.1.2.7 A dealer's premises may be inspected at any time by a fireworks inspector or fire officer.

13.1.2.8 Any person on such premises who fails to comply with a request made by the licensee or his employees in the interest of safety, shall be guilty of an offence.

13.2. FIREWORKS FOR SALE TO THE PUBLIC

13.2.1 The following fireworks are illegal and may not be sold to the public:

- (a) No firecrackers larger than 50 mm long and 12 mm diameter.
- (b) No match crackers or match strike.
- (c) No firecrackers commonly known as "Bombs", e.g. Indian King, King India, Classic Foils etc.

13.1.1.10 Niemand mag op 'n perseel waar vuurwerke aangehou, geberg of gehanteer word, rook of 'n oop lig of vuur daarop neem nie, en niemand word toegelaat om dit te doen nie.

13.1.1.11 Elkeen op sodanige perseel moet hom van watter daad ook al onthou wat geneig is om 'n brand te veroorsaak.

13.1.2 HANDEL

13.1.2.1 Wanneer 'n handelaar in vuurwerke vuurwerke koop of verkry, moet hy 'n behoorlik ingevulde, ondertekende en gedateerde faktuur van die verkoper of verskaffer vereis, wat hy vir 'n tydperk van minstens twee (2) jaar moet hou en wat hy op aanvraag aan 'n inspekteur moet toon.

13.1.2.2 'n Vervaardiger of groothandelaar moet 'n behoorlik ingevulde, ondertekende en gedateerde faktuur met elke verkoop of verskaffing van vuurwerke verstrek.

13.1.2.3 'n Handelaar mag vuurwerke aan die publiek slegs in die **verseëde binneverpakking** soos ontvang van die vervaardiger of groothandelaar, verskaf, met dien verstande dat die verpakking steeds in 'n goeie toestand is.

13.1.2.4 'n Handelaar mag nie vuurwerke aan 'n kind jonger as 16 jaar verkoop of toelaat of duld dat dit aan hom verkoop word nie.

13.1.2.5 'n Handelaar moet aan elke werknemer wat by die verkoop van vuurwerke betrokke is, 'n afskrif van die regulasies en Verordeninge en van die voorwaardes wat op sy handeldryflisensie van toepassing is, verstrek.

13.1.2.6 'n Handelaar moet 'n register hou waarin volle besonderhede van elke transaksie en die voormelde lisensienommer aangeteken moet word. Die register moet voortdurend bygewerk word en te eniger tyd vir inspeksie beskikbaar wees en mag nie tot na die verstryking van twee (2) jaar na die datum van die laaste inskrywing vernietig word nie.

13.1.2.7 'n Handelaar se perseel kan te eniger tyd deur 'n vuurwerke-inspekteur of brandweeroffisier geïnspekteer word.

13.1.2.8 Enigeen op sodanige perseel wat versuim om te voldoen aan 'n versoek gerig deur die lisensiehouer of sy werknemers in belang van veiligheid, is aan 'n misdryf skuldig.

13.2. VERKOOP VAN VUURWERKE AAN DIE PUBLIEK

13.2.1 Die volgende vuurwerke is onwettig en mag nie aan die publiek verkoop word nie:

- (a) Klappers langer as 50 mm met 'n deursnee groter as 12 mm.
- (b) Vuurhoutjeklappers, of klappers wat soos vuurhoutjies oor die swaai van 'n vuurhoutjiedosie getrek word.
- (c) Klappers algemeen bekend as "bomme" bv. "Indian King", "King India", "Classic Foils", ens.

13.2.2 The sale of fireworks must be recorded and all invoices must bear a certificate to the effect that the crackers contain genuine gunpowder (black powder) only.

"The term 'gunpowder' shall include blasting powder and shall mean exclusively gunpowder ordinarily so called, consisting of an intimate mixture of saltpetre (potassium nitrate), sulphur and charcoal, such saltpetre not containing as an impurity perchlorate of potash in greater quantity than one per cent."

13.2.3 All fireworks manufactured in the Republic or imported into it, or which are offered for sale within the Republic shall be marked, labelled and packed in accordance with the Explosives Regulations and any person found in possession of fireworks not so marked and labelled shall be deemed to be in possession of 'unauthorised explosives' and guilty of an offence.

13.2.4 Fireworks shall be packed by the manufacturer or importer in suitable cartons which shall be sealed ready for sale to the public and shall be supplied only to a dealer who is in possession of a valid licence issued in terms of the regulations, and the number of such licence shall be quoted on the invoice.

13.3. USE OR EXPLODING OF FIREWORKS

The discharge of fireworks within the municipal area is unlawful with the exception of the following days:

5 November;

31 December;

1 January; and

the two (2) days of the Deepavali Festival,

and any other day for public display of fireworks if Council's permission is first obtained at least 21 days prior to the event.

13.3.1 It shall be unlawful for any person to use or explode any fireworks —

- (a) within 500 metres of any explosives magazine, explosives factory, petroleum depot or gasometer; or
- (b) in any building or on any public thoroughfare.

13.3.2 No person, other than a technician, shall operate a public display of fireworks on any premises without the written permission of the Explosives Department and the local designated fire officer.

13.3.3 Such permission shall stipulate the conditions to be complied with and non-compliance with any of these conditions shall constitute an offence under this bylaw.

13.3.4 Application for permission to operate a public display of fireworks shall be made in writing and shall set forth —

- (a) the name of the person or organisations sponsoring the display together with the names of the persons actually in charge of the firing of the display who shall be at least 18 years of age and competent for the work;
- (b) the date and time of day at which the display is to be held;
- (c) the exact location planned for the display;
- (d) a description setting forth the age and qualifications of the persons who are to do the actual discharging of the fireworks;
- (e) the numbers and kinds of fireworks to be discharged and the value of the display;
- (f) the manner and place of storage of such fireworks prior to the display; and
- (g) a diagram of the grounds on which the display is to be held showing —
 - (i) the point at which the fireworks are to be discharged, which shall be at least 100 metres from the nearest building, road or railway, and at least 20 metres from the nearest telephone,

13.2.2 Die verkoop van vuurwerke moet aangeteken word en alle fakture moet 'n sertifikaat te dien effekte bevat dat die klappers slegs egte buskruit (swartkruit) bevat.

"Die begrip 'buskruit' sluit springkruit in en beteken uitsluitend buskruit wat gewoonlik so genoem word, bestaande uit 'n intieme mengsel van salpeter (kaliumnitraat), swavel en houtskool, welke salpeter nie kaliumperchloraat as 'n onsuiverheid in 'n groter hoeveelheid as een persent bevat nie."

13.2.3 Alle vuurwerke wat in die Republiek vervaardig of daarheen ingevoer word, of wat binne die Republiek te koop aangebied word, moet ooreenkomstig die Regulasies betreffende Plofstowwe gemerk, geëtiketteer en verpak word, en iemand wat in besit van vuurwerke nie aldus gemerk en geëtiketteer nie, betrap word, word geag in besit van "ongemagtigde plofstowwe" en skuldig aan 'n misdryf te wees.

13.2.4 Vuurwerke moet in geskikte kartonne deur die vervaardiger of invoerder verpak word, wat gereed vir verkoop aan die publiek verseël moet word en mag slegs aan 'n handelaar verskaf word wat in besit van 'n geldige lisensie, uitgereik ingevolge die regulasies, is en die nommer van sodanige lisensie moet op die faktuur weergegee word.

13.3. GEBRUIK OF AFSKIET VAN VUURWERKE

Die afskiet van vuurwerke binne die munisipale gebied is onwettig, met die uitsondering van die volgende dae:

5 November;

31 Desember;

1 Januarie; en

die twee (2) dae van die Deepavali-fees,

en enige ander dag vir die openbare vertoon van vuurwerke indien die Raad se voorafgaande toestemming minstens 21 dae voor die gebeurtenis verkry word.

13.3.1 Dit is onwettig vir enigeen om vuurwerke —

- (a) binne 500 meter van 'n plofstofpakhuis, plofstoffabriek, petroleumdepot of gashouer; of
- (b) in 'n gebou of op 'n openbare deurgang, te gebruik of af te skiet.

13.3.2 Niemand behalwe 'n tegnikus mag sonder die skriftelike toestemming van die Plofstofdepartement en die plaaslike benoemde brandweeroffisier vuurwerke tydens 'n openbare vertoning daarvan op 'n perseel afskiet nie.

13.3.3 Sodanige toestemming moet die voorwaardes voorskryf waaraan voldoen moet word en nienakoming van enige van hierdie voorwaardes maak 'n misdryf kragtens hierdie artikel uit.

13.3.4 'n Aansoek om toestemming om vuurwerke tydens 'n openbare vertoning daarvan af te skiet, moet skriftelik gedoen word en die volgende vermeld:

- (a) die naam van die persoon of instansies wat die vertoning borg, asook die name van die persone wat werklik in beheer van die afskiet van die vuurwerke is, wat minstens 18 jaar oud en bevoeg vir die werk moet wees;
- (b) die datum en tyd van die dag waarop die vertoning gehou gaan word;
- (c) die presiese ligging wat vir die vertoning beplan word;
- (d) 'n beskrywing wat die ouderdom en bevoegdheid van die persone wat die werklike afskiet van die vuurwerke gaan uitvoer, aandui;
- (e) die hoeveelheid en soorte vuurwerke wat afgeskiet gaan word en die waarde van die vertoning;
- (f) die bergingswyse en -plek van sodanige vuurwerke voor die vertoning; en
- (g) 'n plan van die terrein waarop die vertoning gehou gaan word wat die volgende aantoon:
 - (i) die plek waarvandaan die vuurwerke afgeskiet gaan word, wat minstens 100 meter van die naaste gebou, pad of spoorlyn moet wees, en minstens 20 meter van die naaste telefoon-

- telegraph or powerline, tree or other overhead obstruction;
- (ii) the direction in which aerial fireworks, if any, are to be fired;
 - (iii) the area to be kept clear of persons which shall extend at least 50 metres from the front and to the sides of the point at which the fireworks are to be discharged;
 - (iv) the area to be kept clear on which falling residue from aerial fireworks is expected to drop, which shall extend for at least 100 metres to the rear of the firing point; and
 - (v) the location of all buildings and roads within 200 metres of the firing site and of all trees, telegraph or telephone lines or other overhead obstructions at or adjacent to the firing site.
- (h) Completion of an indemnity form absolving Council from any criminal or civil claims.
 - (i) Acknowledgement that authority is at Council's discretion and that the requirements of legislation will be complied with.

13.3.5 At a public display of fireworks it shall be an offence —

- (a) for any person wilfully to enter or remain in that area reserved for receiving falling residue from aerial fireworks;
- (b) for any unauthorised person wilfully to proceed beyond the area demarcated by the organisers of the display for spectators; and
- (c) to disobey the instruction of a uniformed law enforcement officer.

13.4. PYROTECHNIC DISPLAYS

In the event of a pyrotechnic display emergency flares must accompany the displays.

13.5. TRANSPORT OF FIREWORKS

The transport of fireworks shall comply with the conditions as laid down in the National Building Regulations as promulgated in *Government Gazette* No. 3648 dated 8 September 1972.

13.6. USE OF OTHER EXPLOSIVES

Any explosives for the use of which provision is not made in the preceding regulations of these Bylaws, shall be used only in such manner and under such conditions as may be prescribed in writing by an inspector.

13.7. DISTRIBUTION POINTS

The number of distribution points for the sale of fireworks shall be restricted to six.

13.8. PENALTY

Any person who by any act or omission commits a breach of any of the regulations of these Bylaws, shall be guilty of an offence and liable on conviction to a minimum fine of R1000,00 or to imprisonment for a period not exceeding 12 months or to both such fine and such imprisonment, and the explosive, if any, in respect of which the contravention or non-compliance has taken place, may be confiscated, in which case the cost of disposal thereof shall be borne by the accused.

- (h) invulling van 'n vrywaringsvorm wat die Raad van kriminele of siviele eise vrystel;
 - (i) erkenning dat magtiging na die Raad se goeddunke is en dat die vereistes van wetgewing nagekom sal word.

13.3.5 By 'n openbare vertoning van vuurwerke is dit 'n misdryf —

- (a) indien iemand opsetlik daardie gebied wat gereserveer is vir vallende oorblyfsels van lugvuurwerke, binnegaan of daar bly;
- (b) indien 'n ongemagtigde persoon opsetlik buite die gebied wat deur die organiseerders van die vertoning vir toeskouers afgebaken is, gaan; en
- (c) om die opdrag van 'n wetstoepassingsbeampte in uniform te verontagsaam.

13.4. PIROTEGNIËSE VERTONINGS

Indien 'n pirotegniese vertoning gehou word, moet die vertoners noodfakkels by hulle hê.

13.5. VERVOER VAN VUURWERKE

Die vervoer van vuurwerke moet voldoen aan die vereistes soos voorgeskryf in die Nasionale Bouregulasies soos afgekondig in *Staatskoerant* No. 3648 van 4 September 1972.

13.6. GEBRUIK VAN ANDER PLOFSTOWWE

Enige plofstowwe waarvoor nie in die voorafgaande regulasies van hierdie Verordeninge voorsiening gemaak word nie, mag slegs op sodanige wyse en op sodanige voorwaardes gebruik word wat skriftelik deur 'n inspekteur voorgeskryf kan word.

13.8. STRAF
